I/We, the above named person or persons, hereinafter referred to as "Foster Parent", agree to temporary house foster dogs, hereinafter referred to as "Foster Dogs" for Phoenix Paws and Claws Animal Rescue. (PP&CAR) and release Phoenix Paws and Claws Animal Rescue and it's Board Members, Officers, Fosters and Volunteers, jointly and severally, from any and all claims for personal injury and/or property damage to myself or others associated with fostering for PP&CAR.

Terms & Conditions of Fostering

*** Foster Parent must initial beside each Term & Condition**

_____ Foster Dog(s) remains the property of PP&CAR while in Foster care. The Foster Dog(s) will be surrendered immediately upon the request of PP&CAR. Should legal action be necessary to reclaim a Foster Dog(s), the Foster Parent will pay PP&CAR any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms of this Foster Agreement. Any and all decisions, including medical decisions for the Foster Dog will be made by PP&CAR. Foster Parent status can be terminated at any time at the sole discretion of the PP&CAR Board of Directors.

_____ Foster Dog(s) is not to be transferred from the Foster Parent to any other party without prior approval from PP&CAR. Foster Dog(s) shall never be abandoned, sold, given away or turned over to a shelter.

_____ PP&CAR makes no explicit or implicit guarantees in reference to the health and/or temperament of the Foster Dog(s). PP&CAR will provide basic vaccinations, and other required medications. While PP&CAR makes every effort to place only healthy animals in Foster care, PP&CAR does not guarantee the health of any Foster Dog(s) and shall not be held responsible for any expenses other than direct care for the Foster Dog(s) that may be incurred as a result of housing the Foster Dog(s). PP&CAR does not make any warranties regarding health, temperament or whether the Foster Dog(s) is housebroken.

_____ Foster Parent will keep the Foster Dog(s) as a house pet and temporary family member and will not be crated or isolated for excessive periods of time. The Foster Dog(s) is not to live in a garage, in an out-building, in the backyard or any other location where it is not protected from extreme heat or cold. While outdoors, the Foster Dog(s) will always be kept on a leash or in a fenced yard with fresh water always available. The Foster Dog(s) will NEVER be chained or tethered. The Foster Dog(s) will NEVER be permitted to run loose outside of a fenced-in area. The Foster Dog(s) will NEVER be permitted to ride in the back of a pick-up truck, uncontained in an open-air vehicle (jeep or convertible) or left in a vehicle unattended, especially during periods of extreme heat or cold. The Foster Dog(s) must always wear the provided collar with rabies tag and PP&CAR ID tag displayed. The collar must be checked regularly to ensure proper fit. Foster Parent has taken extra precautions to prevent the Foster Dog(s) from getting loose while in Foster care.

_____ Foster Dog(s) will be fed wholesome food daily, given fresh water, adequately exercised, groomed regularly, socialized appropriately and housed indoors in the home as a family member. The Foster Parent will not be compensated for expenses incurred in the normal daily care of the Foster Dog(s) (i.e. food, toys, grooming, etc.). Foster Parent is required to teach basic obedience (house training, crate training, basic manners, etc.)

_____ Foster Dog(s) must be available for adoption during their stay in the Foster home. The Foster Parent will allow the dog to be viewed by Prospective Adopters with 48 hours advanced notice. Foster Parent will return phone calls to Prospective Adopter's within 24 hours of notification. Foster Parent will return all PP&CAR phone calls and emails within 24 hours.

TERMS & CONDITIONS OF FOSTERING (continued)

____ Foster Parent will notify PP&CAR immediately if the Foster Dog(s) becomes ill or injured. Foster Dog(s) medical needs will be approved and paid for at a PP&CAR approved Veterinarian. Foster Parent cannot make a medical decision to euthanize Foster Dog(s) without prior consent from PP&CAR. Foster Parent is not permitted to have a Foster Dog(s) vetted without prior knowledge and consent of PP&CAR. PPCAR Board Members will make all Veterinarian appointments. If a Foster Parent takes a Foster Dog(s) to an unapproved Veterinarian, the Foster Parent is responsible for the payment. Reimbursement for unauthorized vetting is at the sole discretion of the PP&CAR Board of Directors.

PP&CAR DOES NOT PROVIDE OR PAY FOR UNAUTHORIZED BOARDING, GROOMING, FLEA/TICK PREVENTATIVE OR BULK HEARTWORM PREVENTION.

____ Foster Parent will notify PP&CAR of any contact changes (address, phone number, email) within 24 hours of change.

____ Foster Parent will notify PP&CAR immediately if Foster Dog(s) gets loose and is missing.

RELEASE STATEMENT

Foster Parent shall not hold Phoenix Paws and Claws Animal Rescue liable, or responsible for, and Phoenix Paws and Claws Animal Rescue shall be saved and held harmless from and against any and all claims and damages of every kind, for injury to any person or persons, and for damage to or loss of property arising out of or attributed to, directly or indirectly, the operation or performance of Phoenix Paws and Claws Animal Rescue and any of it's Board Members, Officers, Fosters, Volunteers, or Agents under this agreement, including claims and damages arising in whole or in part from the negligence of Phoenix Paws and Claws Animal Rescue. Foster Hereby releases Phoenix Paws and Claws Animal Rescue and all it's Board Members, Officers, Foster, Volunteers and any other Agents or Representatives from any and all responsibility with regarding to Fostering, which the Foster Parent undertakes voluntarily and with full knowledge of the above relase and its implications. .
