This agreement is entered into between Phoenix Paws & Claws Animal Rescue otherwise known as PP&CAR and the undersigned, hereinafter referred to as "Foster".

1. Foster agrees to give the rescued dog food, indoor shelter, and kind and loving care for a limited period of time.
Foster agrees to notify PP&CAR immediately if the animal(s) escape or becomes ill.
2. Foster understands that PP&CAR may not have prior knowledge of the animal(s)'s temperament, and or health conditions.
3. Foster will not seek to hold PP&CAR responsible for damage to property or injury to persons or other pets while foster animal(s) are in the care of foster.
4. PP&CAR will be financially responsible for any veterinary care it deems necessary for the fostered animal(s) at a veterinarian of PP&CAR's choice. If Foster chooses to use another veterinarian that is not an approved veterinarian of PP&CAR, the foster understand they they will be liable for any and all costs.
5. The Foster agrees to bring the animal(s) to adoption events as instructed. Adoption events can occur as often as weekly.
6. Foster agrees that any animal(s) fostered by him/her remains the property of PP&CAR, and that Foster will not relocate the animal from the primary residence of Foster without **prior written notice and approval** of PP&CAR.
7. Foster will return the animal(s) to a PP&CAR representative immediately upon request.
8. If Foster desires to adopt the foster animal(s), and PP&CAR agrees the adoption is appropriate, PP&CAR will provide an Adoption Agreement to Foster. Foster agrees to sign and return said contract within 7 days of receiving it, together with said animal(s)'s adoption fee, unless other arrangements have been agreed to in writing.
